A new year and it's already March! Cold one day and warm the next, Spring is trying to desperately begin. So many flowers and trees have already started to bud and bloom. The fresh smell of new grass wafts through the air as mulch is delivered and the first of the grass cutting begins. There's a newness and excitement in the air as we yearn for a fresh new start. Like everything, Merica House and the residents feel rejuvenated with desires and excitement for the same newness!

Before we can start anew, we must reflect on the old.... What worked? What didn't work? What needs to be altered or changed?

One of the biggest and most puzzling areas of need continues with Merica House having an opening for either a male or female with physical disabilities between the ages of 19-49. We can take anyone who lives in the state of Virginia. A phone call, an application, an interview, it's not that hard. While Merica House is a small but vital living arrangement in Fairfax County, it needs people from outside, like you and me, to "run the show"! The Alliance for the Physically Disabled (APD) is the non-profit group that does just this. We are small in numbers, we have an Executive Board of officers, and we take care of the finances that fund the expenses for Merica House. Our numbers have dwindled though, and we need more volunteers to help out. In particular, we have a great need for some who knows QuickBooks that would be willing to take over as Treasurer. Mitch has been the Treasurer for almost 20 years and just wants a break. Please consider this position and becoming a member of the board at the same time!

There were many positives in the year 2021. Merica House made it through another year of the pandemic. We started to see community venues, like SPARC, reopen, allowing for our residents' participation. We successfully treated a stubborn invasion of bedbugs! We participated in another year of a Fairfax County funded grant and spent a great deal of time rewriting and submitting for another two-year grant. (We expect to hear about whether we succeeded in April). A successful fundraiser, Derby Days, was coordinated by Jennifer Mercer, the sister of two of our residents, Dee and Maureen Shields.

First, and foremost though, Merica House is grateful for the support that you continue to provide! In the last year, your donations helped us make the vital and necessary renovations to the Merica House home. Circuit breaker boxes were upgraded and funding to pay the exterminator was very costly. We replaced all of our computer hardware and systems. Our Service Coordinator, Roxane, started a successful monthly team building program between the great aides from Apex and Hands of Mercy and our residents. These are just a few ways that your contributions have helped.

I know that you and I share the same commitment for helping young adults with significant physical disabilities escape from the challenges of finding a place to live in the community. You be the judge. Look at the photos. Doesn't Scruffy just have the look of a canine who would be dogged in pursuing bed bugs, a dog who will not be denied? And, as for this "rising star" stuff, Scruffy's credentials are pretty impressive too. He graduated

Editor's Note: One of the many responsibilities of our resident services coordinator, Roxane, is to arrange for inspections of the Merica House facilities. Toward that end, Roxane possesses a bulging Rolodex of the names of contractors – some human, some not – who can perform inspections. There are electrical inspectors, inspectors for the clothes dryers, mouse inspectors, bed bug inspectors; you name it, Roxane has an inspector at the ready. Roxane's go-to inspector for bed bugs is a female Labrador mix named Daisy. Why hire a dog to inspect for bed bugs? once heard a story about a former pope. It may have been Pope John Paul II. The story is that the pope was getting out of his car one day and the car door closed on one of his fingers. The pope was in pain. However, his reaction was extraordinary. He

said a small prayer, "Thank you, God, for the opportunity to offer up this pain." The pope's story makes me smile. If pain and discomfort are opportunities for prayer, then myself and my friends at Merica House have plenty of opportunities like that. For individuals living with cerebral palsy, physical movements always present a challenge. Activities that others take for granted, such as putting on one's clothes each day, are difficult for us. Our physical limitations also present difficulties for the aides at

Merica House, who help us get dressed each day. Knowing that the aides have a difficult job, I have resolved to try my best to help the aides when they are doing things for me. As an example, when an aide is attempting to insert my arm into the sleeve of my shirt or jacket, I try to exert a little more effort at moving my arm, so that the aide won't have to make as much of an effort. There is also a physical benefit for me; with the exertion of greater effort on my part, the muscles in my arm become more accustomed to movement and a little stronger.

Each day presents an opportunity for greater physical effort on my part. Yes, there is discomfort and sometimes pain that goes with that effort. I haven't yet reached the point of being thankful for the pain. However, I am thankful for the many blessings that I have been given. For instance, my disability allows me to meet and interact with the aides and many other individuals whom I would not otherwise get to know.

And, unlike Pope John Paul II, I have never caught any of my fingers in the door of a car. For that I say, "Thank God."
